CALL FOR EXPRESSION OF INTEREST (EoI)

for General Contractor Upgrade of Infrastructure Conditions in the Wine Village Rajacke Pimnice 83429961

The Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH is currently implementing its project "EU for Competitiveness through Innovation and Tourism Development", in particular related to upgraded tourism/cultural facilities and stakeholders' skills as part of the Tourism Development Strategy implementation in the Republic of Serbia. This is multi-Donor Action jointly co-financed by the European Union and the Federal Republic of Germany, Ministry for Economic Cooperation and Development and implemented by GIZ.

As part of this project GIZ intends to award Contract for General Contractor - Upgrade of infrastructure conditions in the wine village Rajacke Pimnice.

The scope of work includes:

- 1. Reconstruction of transformation station and public lightning of wine village Rajačke Pimnice;
- 2. Construction of pedestrian paths in the wine village Rajačke Pimnice;
- 3. Construction of the water and sewerage system for the wine village Rajačke Pimnice;
- 4. Construction of well, tank and pressure pipe system for the wine village Rajačke Pimnice;
- 5. Construction of water treatment station for the wine village Rajačke Pimnice.

Tender procedure, from invitation to Tender until signing of the contract, is expected to take place during period *February – April 2023*. Construction work is expected to be performed and completed approximately within 9 months from the signing of the Contract.

To qualify for consideration in the Tender procedure, interested Companies are required to submit the following information and documents for eligibility assessment:

- 1) Official Letter for Expression of Interest,
- 2) Company's details including full company name, full official address, contact information: phone number and email;
- 3) Copy of company's registration record from the Business Registry (APR);
- 4) Company's profile including number of employees (permanent / temporary/in total);
- 5) Confirmation of fully employed engineers with license 400, 410, 430, 450, 453 and person with fire protection license;
- 6) Reference list (*at least* 3 references) of reconstruction and rehabilitation projects under protection as a cultural monument as standalone General Contractor for relevant construction work;
- Evidence of possession of license I090A1 or written authorization of Consortium with company that possess license I090A1.
- 8) Annual total turnover for each of the last three (3) years.

Information and documents specified above shall be submitted to GIZ, in hard copy, in sealed envelope **not later than 21.02.2023 at 15h** to the following address:
