Dear Sirs,

With reference to the above mentioned tender, we would be grateful if you could clarify the following issues:

- Please kindly precise better the payment terms. Please kindly confirm if 40% for pre-payment after signature of the contract and 60% after the signature for provisional acceptance, as per the General conditions

- Please kindly indicate when Final Acceptance certificate will be signed. In Special conditions you quote 100% balance after signature of Final Acceptance. This means that the complete payment will be received only after final acceptance certificate?

- Please kindly indicate what do you intend for solvency report. (Selection Criteria)

- The implementation period of 45 days could be extended of additional 45 days due to the particular product?

- Please kindly confirm that installation and commissioning have to be included and training is not forseen.

- TECHNICAL QUESTIONS:

Regarding the diameter of the rotor. How strict are the dimensions given?

To provide the most suitable machine, what is the material to be milled (PVC, HDPE, etc.)?

What is the type and size of the products to be grinded?

The traction group is needed for sheets or pipes?

What is the maximum size (diameter, thickness, length) of the pipes?

What is the maximum size (thickness, width, length) of the sheets?

What kind of conveyor belt will be used to feed the machine?

ANSWER

Dear Mrs. Cancellieri,

Regarding to your question concerning the tender procedure with reference 2007CB16IPO006-2011-2-110, TD5, 404-34/2014-II/10 - Procurement of Mill for Grinding Plastic, we are providing the following answers:

- Concerning the payment method : After the delivery of the goods, the Provisional Acceptance Certificate will be signed allowing us to test the machine. 15 days after the signing of the Provisional Acceptance Certificate, a Final Acceptance Certificate will be signed. The final Acceptance will be sent to you for signing, after which you will return them together with three (original) Invoices. The payments will be made in full (100% balance) after that. The pre-payment is not possible, due to that the document Special Conditions has precedence over the General conditions.
- A solvency report is a report in which a competent authority of your Country confirms that you were able to, for example, conduct payments, and that
- The term "particular product" is not quite clear, we do not understand what do you mean by that, but generally speaking, all the deadlines in the tender documents, including the implementation period must be respected.
- Training as a position in the tender documentation has not been foreseen.

TECHNICAL SPECIFICATIONS

- the dimensions of the rotor are strictly given in the technical specifications.

- PVC and HDPE in different shapes and sizes will be grinded (parts of plastic chairs and tables, plastic crates...)
- For the rest of the question that are strictly technical, if not detailed in technical specifications, we expect that your products will comply fully to the functionality of the machine and at the same time be according to the of technical specifications given in the tender documents.
